Cellular communication and especially mobile handsets are an essential part of our daily lives. Therefore, they need to be secure and work reliably. But mobile handsets and cellular networks are highly complex systems and securing them is a challenging task. This intentional, measured, and calculated conservative perspective enables us to think on how to best use these flows in the current political situation in Myanmar. It seems therefore useful and relevant to make this data available to our readers.
